Allapattah Flats	SUV permit is not valid on this area.
Big Cypress	SUV permit is not valid on this area.
Crew	SUV permit is not valid on this area.
Dinner Island Ranch	<ol style="list-style-type: none">1. SUV permit is not valid in areas posted as closed or areas closed to hunting as identified on the regulations summary and area map brochure.2. During quota hunt seasons, the SUV permit is only valid in conjunction with a valid Dinner Island Ranch WMA quota permit.3. SUV permit is not valid outside of hunting seasons.
Dupuis	SUV permit is not valid on this area.
Fisheating Creek	SUV permit is not valid on this area.
Holey Land	SUV permit is not valid on this area.
Hungryland	SUV permit is not valid on this area.
J.W. Corbett	<ol style="list-style-type: none">1. SUV permits are not valid outside of hunting seasons.2. SUV permits are not valid in areas designated for still hunting3. During Archery Season the permittee is authorized to take the most direct route to the immediate vicinity of his or her hunting site, stand or blind. Access is unrestricted during other open hunting seasons.

Okaloacoochee Slough	<p>1. In addition to established named or numbered roads, permittee may use service roads or other well-defined roads, trails and fire lanes.</p> <p>2. Permit valid only during periods open for hunting.</p> <p>3. Permit valid only for holders of valid quota permit or checked in hunters during small game season.* *Individuals without a quota permit, not checked in, and/or outside the hunting season will be able to contact the state forest headquarters at 863-612-0776 and apply for a "Forest Use Permit" through the Division of Forestry.</p>
Picayune Strand	<p>1. In addition to established named or numbered roads, permittee may use service roads or other well-defined roads, trails and fire lanes.</p> <p>2. Permit valid only during periods open for hunting.</p> <p>3. Permit valid only for holders of valid quota permit or checked in hunters during small game season.* *Individuals without a quota permit, not checked in, and/or outside the hunting season will be able to contact the state forest headquarters at 239-348-7557 and apply for a "Forest Use Permit" through the Division of Forestry.</p>
Rotenberger	SUV permit is not valid on this area.
Southern Glades	SUV permit is not valid on this area.
Spirit-of-the-Wild	Vehicles may be operated on named and numbered roads year-round. SUV permit is not valid outside of hunting season.
