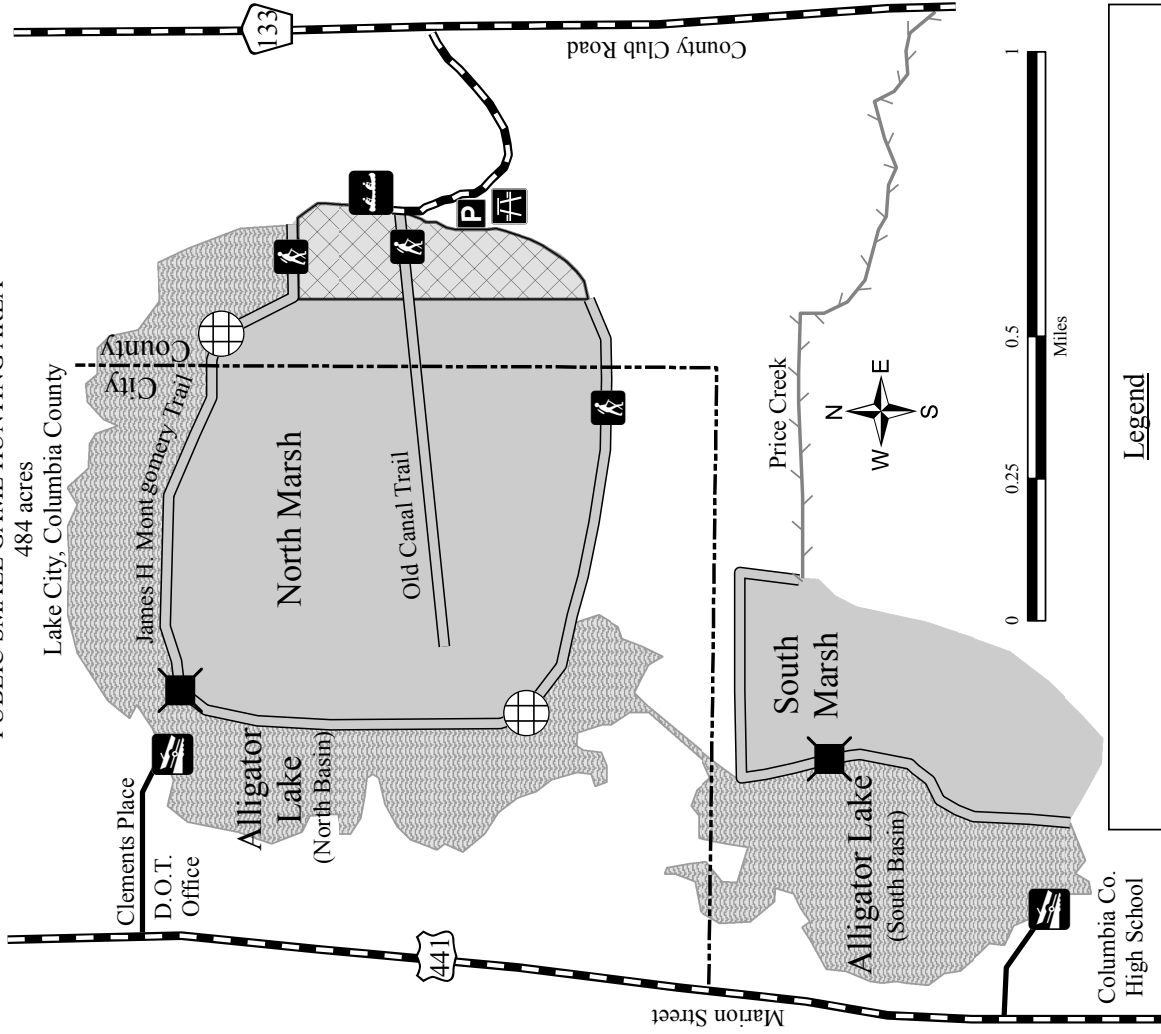

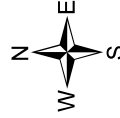
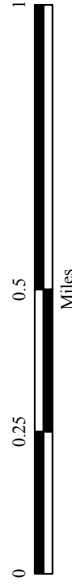

This brochure is designed to provide the public with information and a summary of regulations pertaining to hunting and other recreational use on the Alligator Lake Public Small Game Hunting Area. **Regulations that are new or differ substantially from last year are shown in bold print.** Area users should familiarize themselves with all regulations. For exact wording of the wildlife laws and regulations, see Florida Fish and Wildlife Conservation Commission's wildlife code, on file with the Secretary of State and state libraries. This brochure and the Florida Hunting Regulations handbook should provide the information necessary for you to plan your hunting activities. These publications are available from any Commission office, county tax collector and at MyFWC.com.

Persons using public small game hunting areas are required to have appropriate licenses, stamps and permits. A daily use permit is not required to take wildlife on this area. The following persons are exempt from all license and permit requirements (except for the Migratory Bird Hunting and Conservation Stamp [federal duck stamp]): Florida residents who are 65 years of age or older; residents who possess a Florida Resident Disabled Person Hunting and Fishing Certificate; residents in the U.S. Armed Forces, not stationed in Florida, while home on leave for 30 days or less, upon submission of orders; and children under 16 years of age. Children under 16 years of age are exempt from the federal duck stamp. Anyone born on or after June 1, 1975 must have passed a Commission-approved hunter-safety course prior to being issued a hunting license, except the Hunter Safety Mentoring exemption allows anyone to purchase a hunting license and hunt under the supervision of a licensed hunter, 21 year of age or older, for one year.

Hunting licenses, management area permits, migratory bird permits and Florida waterfowl permits may be purchased from county tax collectors, license agents, at MyFWC.com/license or by telephone at 1-888-486-8356. Any waterfowl hunter 16 years of age or older must possess a federal duck stamp; available at most post offices or duckstamp.com. Americans with Disabilities Act accessibility information is available at MyFWC.com/ADA.

GENERAL REGULATIONS:

All general laws and regulations relating to wild animal life or freshwater aquatic life shall apply unless specifically exempted for this area. Hunting or fishing on this area shall be allowed only during the open seasons and in accordance with the following regulations. The regulations in this brochure pertain only to the Alligator Lake Small Game Hunting Area, which is the north and south marshes and adjacent levees. That portion of Alligator Lake that is outside of the small game hunting area is subject to statewide waterfowl regulations.

1. Taking or attempting to take any game with the aid of live decoys, recorded game calls or sounds, set guns, artificial light, net, trap, snare, drug or poison is prohibited.

2. No person shall cut, damage or remove any natural, man-made or cultural resource without written authorization from the landowner or primary land manager.
3. Public access is prohibited on any portion of the area posted as "Closed" or "Restricted".
4. Releasing any animal is prohibited, without written authorization from the landowner or primary land manager.
5. Construction or use of permanent blinds or structures is prohibited.
6. Tampering with or vandalism of water control structures or other facilities and equipment is prohibited.
7. Alcoholic beverages are prohibited.

PUBLIC ACCESS AND VEHICLES:

1. Alligator Lake Public Recreation Area is closed to public access on Mondays, except for persons accessing the Alligator Lake Public Small Game Hunting Area for the purpose of hunting ducks, geese and coots.
2. During hours open for hunting waterfowl only duck hunters with appropriate licenses and permits are allowed in the marshes and on the levees.
3. Outboard motors may only be used at idle speeds and airboats are prohibited during the entire length of the waterfowl season. All-terrain vehicles (ATVs), motorcycles and tracked vehicles are prohibited at all times.

HUNTERS AND CHECK STATIONS:

1. Access for hunters is allowed only via boat or foot from the boat ramps near the Department of Transportation Office or the Columbia County High School. Two water control structures allow boat access from the lake into the north marsh. Portage over the dikes is allowed at any location.
2. Shooting from dikes, levees or bridges is prohibited.

GUNS:

1. Hunting with firearms other than shotguns is prohibited.
2. Only non-toxic shot approved by the U.S. Fish and Wildlife Service shall be used when hunting duck, geese and coots. Possession of any other type of shotshell is prohibited.
3. Shotguns capable of holding more than three shells are prohibited.

DOGS:

Waterfowl retrievers are allowed only during periods open to hunting.

CAMPING: Camping is prohibited.

BAG AND POSSESSION LIMITS:

Migratory game birds - See Migratory Bird Hunting Regulations pamphlet.

OPEN SEASON - WATERFOWL:

Mondays and Thursdays in the North Marsh; and Mondays, Tuesdays and Thursdays in the South Marsh

Permit, Stamp and License Requirements - Hunting license, management area permit, migratory bird permit and state waterfowl permit and federal duck stamp.

Legal to Take - Duck, geese and coot only.

Regulations Unique to the Small Game Season - In addition to these regulations, all General Wildlife Management Area Regulations shall apply. Shooting hours are from one-half hour before sunrise until noon.

FISHING AND FROGGING:

Allowed year-round except during hours that waterfowl hunting is allowed.

Permit, Stamp and License Requirements - Fishing license (not required when frogging).

Legal to Take - See Florida Freshwater Fishing Regulations Summary.

Regulations Unique to Fishing and Frogging - All General Area Regulations and General Freshwater Fishing Regulations shall apply. For additional information see the Alligator Lake Fish Management Area brochure.
