INSTRUCTIONS

1. Read the application carefully, print or type clearly, and be sure to complete entire application. For assistance, you may contact the Office of Licensing & Permitting in Tallahassee at (850) 487-3122.
2. This form and all fees due must be either hand-delivered to the Florida Fish and Wildlife Conservation Commission or sent by certified mail within 72 hours of being signed and notarized. See front of form for mailing address. The transferee and the transferor should retain a copy for their records.
3. **Transfers will be accepted only from May 1st through midnight last day of February. Requests received by the Commission before May 1st or post marked after the last day of February will not be processed.**
4. The buyer and seller's signature must be notarized.
5. Buyer must hold a current Saltwater Products License with a Purse Seine endorsement in order to receive the Lampara Net endorsement.
6. Seller's Saltwater Products License and Lampara Net endorsement must be current to transfer.
7. Buyer must pay a fee of \$10 to the Commission for the reprinting of their Saltwater Products License with the Lampara Net Endorsement. Seller must pay a fee of \$10 to the Commission for the reprinting of their Saltwater Products License without the Lampara Net Endorsement. Buyer and/or Seller must surrender original Saltwater Products License before transfer will be processed.
8. No person, firm, or corporation shall hold more than two Lampara Net endorsements at any one time.
9. A Lampara Net endorsement cannot be applied to more than one of the applicant's Saltwater Products License at any one time.
10. No Saltwater Products License will be issued with more than one Lampara Net endorsement.
11. In the event of death or permanent disability of a person holding an active Lampara Net endorsement, the endorsement may be transferred by the person or the executor of the person's estate to a member of his or her immediate family within 12 months of the date of death or disability and upon payment of all outstanding fees, fines, or penalties to the Commission in full.
12. Upon receipt of a Lampara Net endorsement, the transferee has three (3) license years, including the current license year, to produce qualifying ballyhoo landings in order to requalify the endorsement. Once requalified, the endorsement will be valid for three (3) license years, **but must still be renewed annually by September 30 of each year.**
