Please read the application carefully, and print or type clearly. You must complete the entire application. This form and all fees due must be either sent by certified mail to FWC Office of Licensing and Permitting, 1875 Orange Ave. East, Tallahassee, FL 32311-6160, or hand-delivered to FWC Office of Licensing and Permitting. Both seller and buyer should keep a copy of this form. The completed form and all fees must be postmarked within **72** hours of the last signature being notarized. Incomplete applications will not be processed, and will be returned to the applicant.
