



This management unit does not include: Lake Seminole east of County Road 271; within 400 feet of the mean-high or ordinary-high waterline or within 400 feet of emergent vegetation bordering state parks, preserves and reserves and any private lands included in management programs governed by Rule 68A-25.032, F.A.C. 

This management unit does not include: the Wacissa River from Goose Pasture north to SR 59; Lake Miccosukee; within 400 feet of the mean-high or ordinary-high waterline or within 400 feet of emergent vegetation bordering state parks, preserves and reserves and any private lands included in management programs governed by Rule 68A-25.032, F.A.C. 



This management unit does not include: the St. Johns River south of SR 40 and north of Channel Marker 15; the Ocklawaha River; the Emeralda Marsh; Haines Creek west of SR 44; Juniper Creek; Lakes Griffin, Apopka, Dora, Beauclair, and Dexter; the Apopka - Beauclair Canal; within 400 feet of the mean-high or ordinary-high waterline or within 400 feet of emergent vegetation bordering state parks, preserves and reserves; and any private lands included in management programs governed by Rule 68A-25.032, F.A.C.
