


Alligator Harvest Unit Maps



The state-owned waters located within the water line of Lake Talquin in Gadsden and Leon counties; north of the Jackson Bluff Dam; excluding more than 50 yards up any connecting natural or manmade waterway except as follows: including that portion of the Ochlockonee River lying between Lake Talquin and the railroad trestle that is located immediately below U.S. Hwy. 90, and those portions of natural waterways lying between Lake Talquin and named roads more specifically described in Rule 68A-23.005(7)(d), F.A.C. 
AMU 734 - Lake Seminole




