

**Background Report**  
**Summary of Changes to Migratory Bird Hunting Seasons, 2019-2020**  
**Consent Agenda Item 1**  
**May 1, 2019**

The proposed federal frameworks for all migratory bird seasons for 2019-2020 have yet to be advertised. The attached tables depict proposed season dates and bag limits for Florida's migratory bird seasons based on the anticipated federal frameworks.

**Migratory Bird Seasons (other than Ducks, Geese, and Coots)**

There are no changes to federal frameworks for dove, rail, moorhen, snipe, and woodcock seasons. Dates and bag/possession limits for the 2019-2020 seasons, based on federal frameworks and Rule 68A-13.008, F.A.C., are as indicated in Table 1.

**Special September Duck Season**

There are no changes to Florida's special September duck season within the federal frameworks. Dates and bag/possession limits for the 2019 season, based on federal frameworks and Rule 68A-13.003, F.A.C, are as indicated in Table 2.

**Regular Waterfowl and Coot Season**

The frameworks have a 60-day season with a six-bird bag limit again for 2019-2020 in Atlantic Flyway states, including Florida.

There are two change to the species' bag limits: the daily bag limit for northern pintails is decreased from two to one and the daily bag limit for mallards is decreased from four to two, only one of which may be a hen. These changes are a result of species-specific harvest management strategies based on parameters such as breeding populations and habitat conditions. Staff recommends changing FWC's rules to allow these changes. If the rule amendment is approved for both advertisement and final adoption, Commission staff will file the rule for adoption as allowed by s. 120.54(3), F.S., without further public hearing. All other daily bag limits will remain the same as last year and as currently contained in Rule 68A-13.003, F.A.C. Details for Florida's season structure based on these required changes and Rule 68A-13.003, F.A.C. are provided in Table 3.

**Canada Goose Season**

There are no changes to federal frameworks for the regular Canada goose season. Dates and bag/possession limits for all phases of the 2019-2020 statewide Canada goose season, based on the federal frameworks and Rule 68A-13.003, F.A.C., are as indicated in Table 4.
