Personnel

By having employees who have the knowledge to understand the rules or facts to properly inform the private land owners when depredation permits are issued by game biologist to harvest deer at night. Neither the FWC employees or the law enforcement agreed or understood the programs in 2010. I was an innocent victim as a result of FWC employees. This caused myself and other private landowners to be fined and loss of hunting license for 1 year. FWC took no responsibility for their lack of knowledge which cost private landowners money and embarrassment.

Have your employees learn how to answer phone calls and return phone calls! Just being honest!

Have IQ above 10! Genuine knowledge and ability

Having more FWC personnel to interact with landowners

High turnover in FWC makes establishing relationships difficult

Hire more biologists rather than foresters.

Hire more staff and increase budget for assistance

learn to do there jobs better and HELP the wildlife, manage there property for the benefit of the animals and the people then maybe they can help the private landowners

Make it easier to get ahold of an officer. Send us a list with phone numbers of officers in our area.

Open themselves up and not be so stuck up. They act like you're below them.

Reaction time when called

The constant turnover of your people has resulted in ZERO follow-up by FWC employees following my interactions and their visits to my farm.

When landowner contacts FWC (Hot line on license) and gives phone number to operator at least receive a call back.

Networking

Consider having personnel co-located w/ USDA-NRCS-FSA - for access purposes

Cooperate with UF/IFAS. Build relationships with private agricultural organizations.

More interaction- attend local meetings of interested parties- maybe Cattlemen, Farm Bureau, extension type meetings just to build relationships

None. They need to go to meetings- introduce themselves to organizations like the FL Growers Blueberry Association, meet growers and ranchers through seminars etc.

I heard years ago that an agency had a program for property management. Once signed into a program, the property was obligated permanently, even if I sell it, the next owner is subject to the same obligations. If true, my interest quickly falls to zero.

I love seeing deer on my property! I don't hunt. I run a business so I am busy- otherwise I would put nest boxes up for bluebirds- maybe in time I will.

I would be interested in bee keeping if you are involved in this area.

I would really like to provide more habitat for wildlife but I don't have time to wade through rules that don't have much common sense. Also some financial help and a list of people who can provide manpower would be beneficial.

I would welcome technical assistance from FWC for land and wildlife mgt- especially turkey habitat

If there are coniferous evergreen trees or other trees available to the public from the state, we would plant and care for them.

I'm interested in perpetuating the use of the entire 25 acres in sustainable agriculture, but possibly combined with eco-tourism, wildlife management etc. and Not having my kids sell it off for development. Any info on that?

I'm interested in raising the quail population it is almost nonexistent on our property

I'm sure you all know what you're doing. Thank you

Many of us have land that should be kept natural in perpetuity, and would welcome the opportunity to sell our development rights. FWC should be using its influence with state leaders to expand the use of Amend 4 funds in purchase of Conservation Easements from willing sellers. Money talks, and developers have a lot of money!

Over the years I have applied for several financial assistance land programs. I've never received a penny and I am always told that there is not enough money. A lot of these programs are a waste of time and are just for show.

Please see comments inside. Wish I could be more help, but I am in the process of selling my property.

Reform property tax laws to give an incentive to landowners to maintain their property in a natural condition. Stop encouraging industrial forestry and the clearing of land for livestock. Prohibit free ranging dogs in rural areas. Increase assistance for prescribed fire.

So called "best management practices" are complete bullshit that helps foresters not wildlife. The FWC is a political organization controlled by the legislature which favors growth over conservation, and does the bidding of farmers and foresters who continue to rape our state. However, I have 1100 acres with a partner that this would be very advantageous. I have looked for this kind of help but didn't receive guidance. Please contact me to look into these programs.

I am aware that our FWC agents are understaffed and underfunded. A concerted effort needs to be made in educating the public school children, hunters, and even law enforcement about wildlife, interactions with wildlife, and wildlife management. It was very helpful when agents gave talks to civic organizations. We should do the same with schools and with any other available venue. Ignorance seems to cause the worst problems for wildlife.

I have really benefited and enjoyed the help and advice of Tony Grossman and Mark Alliston (sp?) over the years.

I have almost 90% destruction of my timber and forest from Hurricane Michael. Also my spring fed pond is breach from hurricane damage. The beavers are actually helping to keep the level up slightly with a small dam. Most of my fruit trees made it through the storm. My pond feeds into econfina creek, I still have bass in the pond, but the level is extremely low. I could use some help repairing the breach and clearing access to my pond. Thank you.

I live in Texas and currently working on Grandmothers house that my sister and I inherited. We come to Florida once or twice a year. Would like to discuss timber management. We'll be in Florida in October.

I purchased land as I found a piece at a fair price. I plan to retire there and for the next 3 years (prior to moving) getting educated in land use and a plan for a wonderful active retirement will be great. Thank you.

I think many landowners resist government involvement with their land because so much interaction is regulatory or punitive. Don't offer any services or programs unless being fully understood by those FWC employees who implement the programs. The private landowner is who suffers not the FWC employee. It cost me \$10,000. Plus no hunting privileges for 1 year. Attorney fees cost a lot.

1) Opening WMA's in NW Florida to all day hunting during spring gobbler, bad move 2) State Cobia regulations too little, too late make them a gamefish

AS A LANDOWNER/HUNTER I HAVE LEARNED THAT HANDICAP HUNTER,S NO LIMMITS HAVE REDUCED HARVESTABLE BUCKS, NO FOODPLOTS IN PUBLICK AREAS REDUCE QUALITY HUNTING IN FL. WMAs. USE DESERET RANCHES AS A MODEL

Catch limit on redfish needs to be increased to at least 2/ person/ day.

Changing doe week to an oddly placed 2-3 days ruined a family Thanksgiving tradition for me and my grandchildren. They can no longer hunt does over TG weekend. The complicated game laws with multiple zones, times, and bag limits have become another way our govt takes and discourages young hunters and fishermen and women. I fear for the future of the outdoor sports! I'd suggest reducing the emphasis on conservation b/c it gives the impression of caring more for the critters than for the sportsmen who pay the bills! Still enforce the laws and regs but reduce the number and complexity of regs. Most of the regs are of questionable value. I don't think using taxpayer dollars to pay landowners is good stewardship of these funds.

Don't want red tape with Government

Game rules have gotten too complicated and seem to be designed to prevent hunting. Doe week shortened without good data. There are still too many does to bucks. Rules for released quail are too complicated and seem unnecessary also expensive for operators of game farms. Too much lip service to conservation!

Have a FWC biologist and officer follow up on feral swine control and safety hunting zones establishment surrounding our property. Thank you.

I just wished the Forestry Dept. would stop taking out the scrub oaks and oak trees these trees produced food for your wildlife that feed your bears and deer, turkeys in our area this is why the poor bears go looking for food. I at one time had problems, but when I found out these bears would be trapped and put to death I was against that. We the people took their land, and like any other animal they are trying to live. I live next to Lake Tracy unit off of Maggie Jones road in Eustis FL. Would love to see FL buy 1 lg piece of property in this area for the animals. This is such a sad problem with the bears that they have no where to live. I just wished people that live in my

area, off Royal Trails, would learn how to live in an area where there is Bears. I wished Fl would buy up more land, if all the tax payers chip in \$5.00 on their taxes it could be done. Any more there will not be any more bears, if FWC keeps putting bears down. I myself have learned to live around these bears. One year I did have a mother bear, that cam in and killed chickens. I was upset at first but when I found out if FWC trapped them they, the bears would be put to death. I am not for that so I sat and watched the mama and 3 cubs stuff dead chickens in forks of trees, for a later meal I just laughed about it whats a few chickens to hungry bears. I say, cut out all Draw hunts in the Lake Tracy unit off Maggie Jones road, and leave it for the animals. During hunting season these animals have no where to go except in people's yards. And then you hear them bitch. In this area you have hunting clubs all over and then you have packs of dogs, running anything they can. Myself, I enjoy going out of a morning drinking a cup of coffee and watching the wildlife, walking around. I just wished I could see fox squirrels around. This is a scene that you can't see in the city. Thank you.

I'm interested in the findings of the 3 point antler rule. What is your assessment? Personally, I have seen more larger and pointed bucks in the last season.

It would greatly benefit private landowners if a boundary was set for hunting in the Chaz. The good hunters know the closer to civilization the deer are less skittish, and if food plots are close. They should be more respectful of private property and land owners next to the Chaz. Stay off their fence lines etc. FWC staff is awesome back here.

It is extremely difficult to acquire doe permits- surrounding states allow doe harvest w/ out difficulties as Florida

My property is adjacent to Deltona- a large residential community. During dry spells, the cattle water tanks here provide the only water source for miles around. Additionally, due to more and more dense development, the farm functions as a food source and refuge to many species of waterbirds, deer, turkeys, and sand cranes. I would very much like to seed the wetlands and other areas with some types of suitable forage,. Current policies seem to doom several areas to the spread of development which threaten water quality (and quantity), wildlife habitat, and food production potential.

Need more boat ramps in Gadsden County no matter who runs or owns boat ramp property (county, state, FWC) and more parking at the few that we have now.

Our land is set aside for nature and wildlife conservation! Unfortunately Walton County encourages barrow pits and landfills to fulfill their needs instead of landowners and residents. See current Rockhill Road barrow pit land use change from agricultural/ residential to "extraction": current exception has protections and will be eliminated! They will probably turn it into a landfill after removing all the soil. Very sad. "Azland Waste Services". Maybe you should attend county commission meeting on July 25!

Recommend that there should be more protection for deer/ bucks with lg. no. of antlers. This blood line should be continued for larger bucks.

Shorten buck season, more day on doe season ratio 5 to 1

Start to manage the bag limits of the deer season. 2 antlered deer per day is obscene. Florida has the most liberal limits in USA. The species has every disadvantage. (2) bucks per years implement

a tag or check in like most other states. Why should any hunter be allowed to take more than (2) bucks per year? No one I know that hunts is starving.

Stop preventing me, a buyer, from developing my property

Strongly disagree with biologist and burn managers on public lands especially hardwood devastation.

Unwise use of public lands- state making major changes to natural habitat such as cutting trees for birds/ signif. reducing cattle grazing ex: AP bombing range. Overgrowth now due to lack of use.

We can't allow the uneducated public allow FWC Board of Directors to be in fear of public outcry to avoid properly controlling the black bear in Florida. They have to be managed!

We have close to 400 acres that since 1980 have designated it Betejay Springs Wildlife Refuge. We protect it from hunting and allow rehab. animals to be released here at a safe place. Seems we don't get any respect from TOR Management FWC for our efforts- seem all they want is to promote hunting! And dog hunting that we are totally against. Cruel!

While I do understand the need for regulations, and your attempts to manage the deer herd for the betterment of all, broad ranging regulations regarding such are B_S_. When I have genetically poor bucks in my deer herd, exhibiting undesirable traits, I should be allowed to take those animals. Ridiculous regulations mandating how many points, and how long horns must be, allow undesirable traits to be passed on to however many future bucks in the herd. Age of that buck, does not change that. In one case in my experience recently, at least 3 bucks expressing undesirable traits were sired by one buck that would not fit your specified horn criteria for at least 4 years after sporting a rack. Those bucks were at least 3 years of age before they met the defined criteria for take. If the one buck sired only 2 fawns each season, that is 8 deer in the herd carrying those undesirable genetic traits, not 3, before he was eligible for take under your regulations. Fact is, he went totally nocturnal, before he was eligible to be taken, and he sired far more than that before dying of old age. This is not to mention regulations limiting the number of deer taken each season, while incorporating language regarding depredation permits. If the population is high enough to mandate a depredation permit, obviously the need for limiting take is questionable, in your broad encompassing regulations. As for FWC's management of the present bear population in the state, the 2015 season allowed, proved beyond all shadow of doubt, that FWC has not a clue what the bear population truly is in the state of Florida, although hunters repeatedly told FWC during public meetings on the Black Bear Management Plan that the population was higher than suggested. When the unit containing the last 2 counties in the state that had a legally allowed bear season, because bear migrate out of the Okefenokee Swam into those 2 counties, reported only 2 kills, and I have neighbors reporting 8 bear in a single group passing through their feed plots, reporting 17 different bear on camera in their backyard in a matter of 5 months, and I can drive 3 miles down one road and count a dozen or more different bear tracks crossing said road, knowing at least 2 bear that frequent that stretch of road routinely were not among those tracks seen, there are certainly MORE than 2 bear residing here, to be taken. The management plan is out of line. Period! There are FAR MORE BEAR in the state of Florida than FWC admits. Unfortunately, it is obvious that the only thing that gets the attention of FWC on this matter, is NUMEROUS demands to the Governor's Office for a bear season, for the sake of human safety, following several bear attacks on humans. Is there some reason people have to be attacked to get a season opened on Bear in the state of Florida?

Furthermore, the Black Bear Management Plan cited studies that would suggest the population should have been 4 times that claimed in 2012 meetings on said plan. And, studies in the Ocala National Forest on reproduction to adulthood proved that survival rate in the state of Florida was twice that of the study cited in the management plan. That study would have placed bear population in the state in 2012 at 24 - 30 thousand bear, and expanding exponentially at a far greater rate than suggested. Open a damn season on them, and manage them! Quit conceding to the special interest groups!! And, quit obfuscating all game regulations to the point that no one wants to hunt or fish anymore. The hunting and fishing regulations in this state are reaching a point where everyone needs a damn degree in law to participate in any outdoor activity beyond birdwatching. It is absolutely ridiculous. No, I don't want to participate in your programs, I don't want you anywhere near my land with all of your B_S_ regulations. That is the stewardship you people are fostering in this state; thank you!

General Information

[We] own approximately 90,000 in Escambia and Santa Rosa City, FL. Managed by Resource Management Service. Land is leased to hunting clubs and under QDMA management.

90 acres, mostly pasture scattered trees especially on or near fence rows. About 5 or 6 acres of woods. Very wildlife friendly, little or no hunting.

After H. Michael in Oct. my 40 acres of trees have become 40 acres and 40 trees. I'm too old to do much cleaning up, burning, etc.

As a PhD biologist and scientist, I have credentials for assessing and managing our property without too much outside help.

Before Hurricane Michael I had approx. 20+ acres of pine and hardwood forest. All that is left is a few trees, the rest are broken or uprooted. It will be years before it could be restored if ever.

Biologists were great. IFAS helpful Federal- a little too much bureaucracy Thanks!

Can't rate FWC biologist- because haven't met one.

Commission is doing a great job for Florida - Thank you

I have 100 acres and I was told my farm is not big enough for any gov. assistance

I have never visited my property that I inherited from my mother. I have received a letter from a man who wanted to lease my land for hunting. I have received letters from developers. I don't like people prying into my land records. It's harassment. I plan to visit my property this year. I am leaving my property to my son when I die, he can decide what to do.

I have owned 20 acres of pine forest land for around 25 years. The land remains in its natural state with no active management.

I like the job FWC does and I like to see their presence around the state.

I live out of state however I practice land management at home state. I know the work involved and due to distance and equipment I can not implement a program. Thank you.

I own 32+ acres of wooded property which is unused. It is maintained by mother nature only.

I own vacant land next to a sub-division that has very little wildlife habitat potential.

I sold a part of my land but the rest lays as uncontrolled timber land with a little wet land. Has water running through it as well. But good dry frontage.

I was not aware of any of these programs. I have not been to the property for many years. I do rent about 40 acres to a neighbor who I believe grazes cattle on it.

I'm 91 on walker but have son and grandson that will take over.

Most of the land is in a trust that is leased for pasture land. I have no contact on a regular basis with that individual (please do not send this survey again)

My farm is lcoated between High Springs and Newberry FL one mile east of the Alachua Gilchrist County line. I was raised on this farm. In my younger days, dove, quail, and gopher tortoises were plentiful. No deer or squirrels were present at all. Now its reversed. Squirrels are plentiful and I see deer sign frequently. Coyotes are plentiful. They were probably the demise of the gopher t. and quail population. The coyote was introduced into an environment with no natural predators.

My husband passed away 4/24/19

Nothing about gopher turtles- Have plenty of these

Our 20 acres of land are available for sale.

Our donkey keeps coyotes and other predators from our cows and horses or raises an alarm. With only 36 acres, mostly pastures, and no water, we don't have much of a habitat for local wildlife.

The land is hunting residential. It is not developed yet. It is held in trust, specified to be given to a daughter. However, it can be sold before the beneficiaries get the trust settlement.

The particular parcel you are inquiring about is 48 ac. held for future development on a major highway. No kind of management in place

The properties in question are held in a family trust and are currently being liquidated by the family, hence we are not pursuing these wildlife and land use management opportunities.

This was mailed to my Family LLP. I also won land individually- All totaled 60 acres with 3 20 acre tracts

Three party ownership- two will do

To my knowledge 55 acres has never been burned off. Husband died 4 years ago from cancer. More dead trees pines and oak this year- tried to have them cut down close to house but they cost too much money. Trees were small when we built the house but now they are bigger and danger of falling on the house. I have 10 brier goats, one donkey, two dogs, two cats, 12 chickens. Have free range deer and turkeys.

Try to grow veggies for the year (peas, corn, okra) deer eats it all

Very limited hunting on my property. Reported bear sighting and panther sighting on the property.

We are selling all our vacant land that isn't under development.

We are using one [management plan] just not in writing

We managed 40,000 acres

We have as many as 100 turkeys grazing the pastures. Sandhill cranes, eagles & osprey from the LWNWR, gopher tortoises. When planting a garden, wildlife takes its share. We also have deer grazing pasture.

We keep up and do well with our property- planted pines and wildlife

We live on the farm where my husband was born and have been married 56 years. Our son leases the majority of our land for a hay operation. We feed birds and enjoy watching them as well as the deer and turkeys (and of course squirrels and fox squirrels) that live in our wooded areas.
