

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received subgrant applications for Florida Fish & Wildlife Conservation Commission repairs to (3) Floating Docks due to damages in Hurricane Michael (DR-4399-FL. Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for projects under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 30, 2018, for Hurricane Michael. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a cumulative final notice for FEMA's funding action located within the floodplain. FEMA has determined that the only practicable alternative is to locate facilities (Floating docks) at its original location within the floodplain because the facility is either functionally dependent upon its location within the floodplain or promotes open space use.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state, and local laws, regulations, floodplain standards, permit requirements, and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

Locations of the Proposed Work:

Proposed Work and Purpose:

SOW: Florida Fish & Wildlife Conservation Commission, Bay County [Site 1 (30.170220, -85.753264); Site 2 (30.16973, -85.75326); Site 3 (30.170220, -85.753264); Site 4 (30.170649, -85.753295) (30.170649, -85.753295), Cat E, 33% complete, The applicant utilized contracts for the following repairs: Completed Work – Site 1: Replaced fencing and barbwire components, Work To Be Completed – Site 2: Repair aluminum soffit; Site 3: Replace soffit, downspouts, and gutter other components; Site 4: Replace (2) Safe Haven floating docks 30 FT x 11 FT, (1) Safe Haven floating dock 24 FT x 11 FT, 12'' hoop pile ring holder, dock T connection brackets, dock connection plates, (1) pontoon; restoring these facilities back to pre-disaster design, capacity and function and capacity within the existing footprint.– DOC 1991, Cost \$65,261.37

Project Alternatives:

The alternative that has been considered is the no action alternative. This alternative is not feasible as the floating docks will remain vulnerable to flood risk, including property damage and hazards to human life and safety. With the no action alternative, surrounding properties and residents within the community may experience continued negative impacts. Alternate locations were not considered as the floating docks are functionally dependent upon its location within the floodplain.
