

How to report harvest online at GoOutdoorsFlorida.com

Log into or create an account at GoOutdoorsFlorida.com by clicking the “Harvest Reporting” option on the login screen. *Note: Exempt hunters can create an account by selecting “Create New Account” as their login option or can submit their harvest report without a customer account by selecting the “Exempt Hunter” option on the login screen. Non-exempt hunters **must** submit through a customer account.*
