#### To submit an application:

- In the GoOutdoorsFlorida system, navigate to the Customer Lookup Screen and enter the customer’s date of birth and CID, Florida DL, or the last four digits of the customer’s SSN and last name.
- Under the Customer Detail section, select *Apply for Limited Entry/Quota*.
- Choose the appropriate application and proceed through with prompts according to the customer’s requests.
- Verify all permit choice information before submitting and print the document receipt for the customer.
