**Wildlife Management Area Antlerless  
Deer Permits**

The Fish and Wildlife Conservation Commission of the State of Florida, acting under the authority of Article IV, Section 9 of the Florida Constitution and Rule 68A-15.005(4), Florida Administrative Code (F.A.C.), hereby establishes the number of antlerless deer permits to be issued on specified Wildlife Management Areas for designated periods of the 2020-21 hunting season as follows:

<b>SOUTHWEST REGION</b>	
▪ Green Swamp-West, archery (2 hunts with 26 each)*	52
▪ Green Swamp-West, general gun (3 hunts with 12 each)*	36
<b>NORTH CENTRAL REGION</b>	
▪ Andrews, supervised youth (2 hunts with 5 each)	10
▪ Camp Blanding, still, general gun (4 hunts with 5 each)	20
<b>NORTHWEST REGION</b>	
▪ Blackwater, general gun still (valid only during the quota period: Nov 26-29, Dec 19-27, Jan 25 – Feb 10; and only in that portion of the Still Hunt Area east of Beaver Creek Road, Hurricane Lake Road, Old Martin Road, and Norman Riley Road; and north of U.S. Highway 90)	290
▪ Blackwater, general gun dog (2 hunts with 30 each; valid only in that portion of the Dog Hunt Area east of Beaver Creek Road)	60
▪ Box-R, archery (2 hunts with 20 each)	40
<b>NORTHEAST REGION</b>	
▪ Ft. Drum, general gun*	20
▪ Half Moon, archery (2 hunts with 25 each)	50
▪ Half Moon, muzzleloading gun	10
▪ Rock Springs Run, muzzleloading gun (2 hunts with 30 each)	60
▪ Rock Springs Run, general gun (2 hunts with 30 each)	60
▪ Seminole Forest, mobility-impaired	15
▪ Seminole Forest, muzzleloading gun	15
▪ Seminole Forest, general gun (2 hunts with 15 each)	30
▪ Seminole Ranch, muzzleloading gun (2 hunts with 10 each)	20
▪ Seminole Ranch, general gun	10
▪ Triple N Ranch (3 hunts with 10 each)*	30
