

Executive Order No.: EO 11-24

Fall Special-Opportunity Hunt Permits

The Fish and Wildlife Conservation Commission of the State of Florida, under Article IV, Section 9 of the Florida Constitution and Rule 68A-15.005, F.A.C., hereby alters the fall special-opportunity hunt permit quotas as established in Executive Order No. EO 11-23 dated 13 September, 2011 as follows due to a technical error in the licensing system that resulted in overselling fall special-opportunity hunt permits:

Green Swamp, West Unit, special-opportunity archery, Nov. 5-8, 2011 hunt – up to 58 (no exemptions).

Green Swamp, West Unit, special-opportunity archery, Nov. 17-20, 2011 hunt – up to 61 (no exemptions).

Green Swamp, West Unit, special-opportunity general gun, Jan. 26-29, 2012 hunt – up to 59 (no exemptions).

Green Swamp, West Unit, special-opportunity general gun, Feb. 6-9, 2012 hunt – up to 59 (no exemptions).

Green Swamp, West Unit, special-opportunity general gun, Feb. 15-18, 2012 hunt – up to 58 (no exemptions).

Fort Drum, special-opportunity deer – up to 23 (no exemptions).

Lake Panasoffkee, special-opportunity archery, Oct. 4-7, 2011 hunt – up to 23 (no exemptions)

Lake Panasoffkee, special-opportunity archery, Oct. 13-16, 2011 hunt – up to 21 (no exemptions)

Lake Panasoffkee, special-opportunity archery, Oct. 25-28, Nov. 3-6, Nov. 15-18, and Dec. 1-4, 2011 hunts – 20 (no exemptions)

Lake Panasoffkee, special-opportunity archery, Dec. 13-16, 2011 hunt – up to 21 (no exemptions)

Triple N Ranch, special-opportunity deer hunt, Oct. 15-21, 2011 hunt – up to 18 (no exemptions).

Triple N Ranch, special-opportunity deer hunt, Oct. 29-Nov. 4, 2011 hunt – up to 17 (no exemptions).

This order shall take effect upon execution and shall remain in effect expire at 12:01 a.m. on 19 February 2012 or until superseded by subsequent order.
