

Executive Order Number: EO 13-37

**Operation Outdoor Freedom Dove Hunt  
on Blackwater Wildlife Management  
Area – Hutton Unit**

The Florida Fish and Wildlife Conservation Commission, pursuant to Article IV, Section 9, of Florida Constitution, and Rule 68A-15.004, F.A.C., hereby authorizes the following special outdoor recreational opportunity to be administered by the Florida Forest Service (FFS) on Blackwater Wildlife Management Area – Hutton Unit consistent with 589.19, Florida Statutes.

**OPEN SEASON**

Special dove hunt: October 5, 2013.

**LEGAL TO TAKE**

Mourning dove, Eurasian collared dove, white-winged dove, and rock dove only.

**PERMITS**

A Florida Forest Service permit shall be required to hunt the area consistent with 589.19, Florida Statutes. A maximum of eight (8) permits shall be issued to eligible veterans and service members by the Florida Forest Service for this hunt. Additionally, a maximum of four (4) permits shall be issued to official hunt guides as determined by the FFS for this hunt.

**SPECIFIC AREA REGULATIONS**

In addition to the regulations contained in Rules 68A-13.008, 68A-15.004 and 68A-15.063(5), F.A.C., the following regulations shall apply:

- 1) Hunting by OOF participants is allowed on FFS designated dove fields only.
- 2) Florida Forest Service permit holders (except official hunt guides) may be accompanied by non-hunting assistants.
- 3) Only the Florida Forest Service permit holder may harvest doves.
- 4) Florida Forest Service permit holders may use all-terrain vehicles throughout the area during the special dove hunt as necessary for mobility-impaired accommodation purposes.
- 5) Florida Forest Service permit holders and their non-hunting assistants are required to operate vehicles on named or numbered roads, except for mobility-impaired accommodation purposes.
- 6) Any provisions of Rules 68A-15.004 and 68A-15.063(5), F.A.C., which are inconsistent herewith, are hereby superseded.

This order shall take effect upon signing and shall remain in effect until 11:59 p.m. on 5 October 2013.
