

The Fish and Wildlife Conservation Commission of the State of Florida, acting under the authority of Article IV, Section 9 of the Florida Constitution, and Rule 68A-15.005(3), F.A.C., hereby establishes the number of antlerless deer permits to be issued on selected Wildlife Management Areas for designated periods of the 2014-15 hunting season as follows:

Half Moon, archery (2 hunts with 25 each)	50
Half Moon, muzzleloading gun	5
