

Order Number: EO 15-23**Antlerless Deer Permits on Selected
Wildlife Management Areas**

The Fish and Wildlife Conservation Commission of the State of Florida, acting under the authority of Article IV, Section 9 of the Florida Constitution and Rule 68A-15.005(4), Florida Administrative Code (F.A.C.), hereby rescinds Executive Order number EO 15-20 and reestablishes the number of antlerless deer permits to be issued on selected Wildlife Management Areas for designated periods of the 2015-16 hunting season as follows:

Green Swamp-West, archery (2 hunts with 26 each)*	52
Green Swamp-West, general gun (3 hunts with 12 each)*	36
NORTH CENTRAL REGION	
Andrews, supervised youth (2 hunts with 5 each)	10
Camp Blanding, still, general gun (4 hunts with 5 each)	20
Flying Eagle, muzzleloading gun	5
Flying Eagle, general gun (2 hunts with 5 each)	10
Jennings Forest, muzzleloading gun	5
Jennings Forest, general gun (4 hunts with 5 each)	20
NORTHWEST REGION	
Blackwater, general gun still (valid only during the quota period: Nov 26-29, Dec 19-27, Jan 25 – Feb 10; and only in that portion of the Still Hunt Area east of Beaver Creek Road, Hurricane Lake Road, Old Martin Road, and Norman Riley Road; and north of U.S. Highway 90)	120
Blackwater, general gun dog (2 hunts with 15 each; valid only in that portion of the Dog Hunt Area east of Beaver Creek Road)	30
Box-R, archery (2 hunts with 20 each)	40
NORTHEAST REGION	
Ft. Drum, general gun*	20
Half Moon, archery (2 hunts with 20 each)	40
Lake Panasoffkee, archery (8 hunts with 3 each)*	24
Rock Springs Run, muzzleloading gun (2 hunts with 30 each)	60
Rock Springs Run, general gun (2 hunts with 30 each)	60
Seminole Forest, mobility-impaired	15
Seminole Forest, muzzleloading gun	15


