**Closure of Commission-Managed  
Areas in the South Region**

The Fish and Wildlife Conservation Commission of the State of Florida, acting under the authority of Article IV, Section 9, of the Florida Constitution, and pursuant to FWC Executive Order Number EO-17-35, and Executive Order of the Office of the Governor EO-17-235, and Rule 68-1.009, F.A.C., hereby closes commission-managed areas in the South Region as indicated below. These closures are necessary to ensure public safety during an extreme weather event Hurricane Irma.
