**DRAFT RULE**

**RULE NO:** 68A-15.063

**RULE TITLE:** Specific Regulations for Wildlife Management Areas –  
Northwest Region

**PURPOSE AND EFFECT:** The purpose of the proposed rule amendment is to revise specific area regulations on Wildlife Management Areas (WMAs) in the Northwest Region and conform to calendar year date changes. The effect of the proposed rule amendment will be to enable the agency to better manage fish and wildlife resources and public use on WMAs.

**SUMMARY:** The proposed rule amendment would adjust season dates to conform to calendar year changes and revise specific area regulations on Wildlife Management Areas (WMAs) in the Northwest Region as follows:  
Apalachicola WMA, Bradwell Unit – add a youth spring turkey hunt (quota of 3, no exemptions); add a scout day between the two archery hunts; and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Aucilla WMA – allow the use of dogs to hunt wild hog during small game season.

Blackwater WMA, Hutton Unit – allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Box-R WMA – allow the take of wild hog during small game season; prohibit the use of dogs to take wild hog during the small game season; and move the second general gun season hunt to the end of January to better capture the rut.

Chipola River WMA – allow access to improved recreational areas from sunset to sunrise only to individuals participating in authorized hunting and/or fishing activities, actively launching/retrieving a boat or authorized to camp within the area; and establish five 3-day wild hog-still season hunts (one per month from May through September).

Choctawhatchee River WMA – allow access to improved recreational areas from sunset to sunrise only to individuals participating in authorized hunting and/or fishing activities, actively launching/retrieving a boat or authorized to camp within the area; and allow raccoon hunting at night by the aid of a light and dogs during the general gun and small game seasons.

Econfina Creek WMA – allow access to improved recreational areas from sunset to sunrise only to individuals participating in authorized hunting and/or fishing activities, actively launching/retrieving a boat or authorized to camp within the area; and allow through hikers on the Florida National Scenic Trail to camp in designated campsites along the trail without obtaining a camping permit.

Eglin AFB WMA – clarify that a Department of Defense-issued permit is required for all recreational users on the area.

Escambia River WMA – allow access to improved recreational areas from sunset to sunrise only to individuals participating in authorized hunting and/or fishing activities, actively launching/retrieving a boat or authorized to camp within the area; and establish five 3-day wild hog-dog season hunts (one per month from May through September).

Joe Budd WMA – add the allowance to use modern shotguns during the youth turkey hunt; and change the issuance of spring turkey season daily quota permits first-come, first-served at the check station to random draw via the Commission's Recreational License Issuance Services (RLIS).

Lafayette Creek WMA – establish a wild hog-still season hunt during February; and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Ochlockonee River WMA – establish five 3-day wild hog-still season hunts (one per month from May through September); and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Perdido River WMA – allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Pine Log WMA – allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Point Washington WMA – clarify that camping is prohibited, except when camping in designated campsites by permit from the Florida Forest Service; and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Talquin WMA – establish five 3-day wild hog-still season hunts (one per month from May through September); and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Tyndall WMA – allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season in areas and during days designated by the Installation Commander.

Wakulla WMA – expand the first archery season hunt from two days (Saturday and Sunday) to three days (Saturday through Monday); and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Yellow River WMA – allow access to improved recreational areas from sunset to sunrise only to individuals participating in authorized hunting and/or fishing activities, actively launching/retrieving a boat or authorized to camp within the area; remove the designation and boundary for the Burnt Grocery Creek Unit and regulate this area with Yellow River WMA rules; remove the quota permit requirement during the youth spring turkey hunt; allow hunting during the youth spring turkey hunt on the entire WMA; and allow any dog for hunting small game (quail, rabbit, squirrel and migratory birds) during small game season.

Additionally, the proposed rule amendment would provide non-substantive technical changes, such as grammatical corrections, language standardization, or clarification of an existing rule.

### **THE FULL TEXT OF THE PROPOSED RULE IS AS FOLLOWS:**

68A-15.063 Specific Regulations for Wildlife Management Areas – Northwest Region.

(1) Apalachee Wildlife Management Area.

(a) Open season:

1. General gun – November ~~23-26~~ ~~24-27~~ and December ~~9~~ ~~10~~ through February ~~11~~ ~~12~~ (Mondays, Wednesdays and Fridays closed to hunting in Zones A and B, except hunting is allowed the Friday after Thanksgiving).

2. Archery – October ~~21~~ ~~22~~ through November ~~19~~ ~~20~~.

4. Muzzleloading gun – December ~~2-4~~ ~~3-5~~.

5. through 7. No change.

8. Quail (Zone A) – December ~~19~~ ~~20~~ through January ~~28~~ ~~29~~ (Mondays, Wednesdays and Fridays closed to hunting).

9. Spring turkey (Zones B and C) – March ~~17~~ ~~18~~ through April ~~22~~ ~~23~~ (Fridays, Saturdays and Sundays only).

(b) through (d) No change.

(2) Apalachicola Wildlife Management Area.

(a) Open seasons:

1. General gun – November ~~23-26~~ ~~24-27~~ and December ~~9~~ ~~10~~ through ~~January 31~~ ~~February 1~~.

2. Small game – November ~~11-22~~ ~~12-23~~, November ~~27~~ ~~28~~ through December ~~8~~ ~~9~~ and February ~~1~~ ~~2~~ through March ~~4~~ ~~5~~.

3. No change.

4. Youth turkey hunt – March ~~10-11~~ ~~11-12~~.

5. Spring turkey – March ~~17~~ ~~18~~ through April ~~22~~ ~~23~~.

6. Archery – October ~~21~~ ~~22~~ through November ~~19~~ ~~20~~.

7. Muzzleloading gun – December ~~2-4~~ ~~3-5~~.

8. Muzzleloading gun and archery – February ~~1-11~~ ~~2-12~~.

9. No change.

10. Fox, raccoon, opossum and bobcat – October 1 through March ~~4~~ ~~5~~ in that portion of the area in Liberty County lying west of State Road 65 (except in that portion of the area lying north and east of the Florida River and Larkins Slough) and in that portion in Leon County and Wakulla County south of State Road 267 bounded on the east by Forest Roads 313, F.H. 13 and 356, on the south by Forest Roads 349 and 357, on the west by Forest Roads 348 and F.H. 13, 309, 314 and 344.

11. Trapping – February ~~1~~ ~~2~~ through March 1.

12. through 13. No change.

(b) Legal to take: All legal game, bear (only during the bear season), fish, frogs and furbearers. Taking of antlered deer not having at least one antler with two or more points is prohibited, except by persons less than 16 years of age. Bearded turkeys or gobblers may be taken during the muzzleloading gun season, and during the periods of November ~~23-26~~ 24-27 and December ~~9-20~~ 10-21. Taking quail is prohibited on the quail enhancement area (that portion of the area lying north of Oak Ridge Road, east of State Road 61 and U.S. Highway 319, south of State Road 263 and west of State Road 363) except during quail season as established annually by order of the Executive Director, based on annual fall quail surveys. The daily bag limit for quail on the quail enhancement area is six (6) per person.

(c) No change.

(d) General regulations:

1. Bird dogs may be trained from June 1 through March ~~4~~ 5, except on the quail enhancement area where bird dogs may be trained November 1 through December 31. Deer dogs may be trained from October ~~28~~ 29 through November ~~16~~ 17 in that portion of the area open to hunting fox, raccoon, opossum and bobcats.

2. through 7. No change.

(3) Apalachicola Wildlife Management Area – Bradwell Unit.

(a) Open season:

1. General gun – November ~~23-26~~ 24-27 and December ~~9-13~~ 10-14.

2. Archery – October ~~21-27~~ 22-28 and October 29 through November 6.

3. Muzzleloading gun – December ~~2-4~~ 3-5.

4. Family hunt – December 22-24, January ~~19-21~~ 20-22 and February ~~2-4~~ 3-5.

5. Small game – Opening 12 days prior to the zonal antlered deer season and closing 8 days thereafter, and reopening on the first Saturday following the close of the first family hunt and closing 8 days thereafter ~~November 12-20 and December 31 through January 8.~~

6. Spring turkey – March ~~17-18~~ 18-19 and March ~~30~~ 31 through April ~~1~~ 2.

7. Wild hog-dog – July ~~14-16~~ 8-10, August ~~4-6~~ 5-7 and September ~~1-3~~ 2-4, ~~2017~~ 2016, and May ~~4-6~~ 5-7 and June ~~1-3~~ 2-4, ~~2018~~ 2017.

8. Wild hog-still – July ~~21-23~~ 15-17, August ~~18-20~~ 19-21 and September ~~15-17~~ 16-18, ~~2017~~ 2016, and May ~~18-20~~ 19-21 and June ~~15-17~~ 16-18, ~~2018~~ 2017.

10. Youth turkey hunt – March 10-11.

10. renumbered 11. No change.

(b) Legal to take: All legal game, bear (only during those portions of the archery season that coincide with the open season established for the East Panhandle BMU in Rule 68A-13.004, F.A.C), fish, frogs and furbearers. Taking of antlered deer not having at least one antler with two or more points is prohibited, except by persons less than 16 years of age. The bag limit for antlered deer shall be one per quota permit during the archery season and one per person, but no more than two per quota permit during muzzleloading gun and general gun seasons. During the family hunt, the bag limit shall be one antlered and one antlerless deer per quota permit. During spring turkey season, one gobbler or bearded turkey may be taken per person, but not more than two per quota permit. During the youth turkey hunt, one gobbler or bearded turkey may be taken per quota permit. During the wild hog seasons, only wild hog may be taken.

(c) No change.

(d) General regulations:

1. No change.

2. Taking wildlife with dogs, other than bird dogs and retrievers, is prohibited, except during the wild hog-dog season and any dog may be used to take small game during the small game season. The take of wild hog with dogs is prohibited during the small game season.

3. through 5. No change.

(4) Blackwater Wildlife Management Area.

(a) Open seasons in the still hunt area (which includes that portion of the area south of State Road 4, except for the field trial area, and that portion of the area north of State Road 4, except for the dog hunt area).

1. General gun – November ~~23-26~~ 24-27 and December ~~16~~ 17 through February ~~7~~ 8.

2. Family still hunt – December ~~9-10~~ 10-11.

3. Small game – November ~~11-22~~ 12-23, November ~~27~~ 28 through December ~~15~~ 16 and February ~~8~~ 9 through March ~~4~~ 5.

(b) Open seasons in the dog hunt area (which includes that portion of the area north of State Road 4 and west of Three Notch Road, east of Mason West Road, and north of Camp Henderson Road; and that portion of the area north of State Road 4, west of Beaver Creek Highway and Hurricane Lake Road, and east of Belandville Road; and that portion of the area north of Forest Road R47, north of Eadie Cotton Road and Peaden Bridge Road, west of Sherman Kennedy Road, south of Mattie Kennedy Road and Kennedy Bridge Road, west of Bullard Church Road, and east of Beaver Creek Highway and Hurricane Lake Road):

1. General dog dog – November ~~23-26~~ ~~24-27~~, December ~~16~~ ~~17~~ through ~~December 31~~ ~~January 1~~ and January ~~15~~ ~~16~~ through February ~~7~~ ~~8~~.

(c) Open seasons in the field trial area (which includes that portion of the area bounded by Coldwater Creek on the northwest, the western boundary of Blackwater State Forest to the west and south, County Road 191 on the southeast, and on a line running west 3/4 mile from the intersection of County Road 191 and Coldwater Horse Trail, then north one mile and then three miles west to Coldwater Creek at a point 1/2 mile northeast of the Coldwater Recreation Area):

Taking wildlife with dogs, other than bird dogs or retrievers, is prohibited in the still hunt area, field trial area and during general gun still and family still hunt in the dog hunt area; however, dogs with a shoulder height of 15 inches or less may be used to take small game during small game seasons in both the still hunt and dog hunt areas and dogs of any size or breed may be used throughout the area during the wild hog-dog season. The take of wild hog with dogs during the small game season is prohibited. Dogs are prohibited in the field trial area, except as specifically authorized by permit, or during the bird dog training, dove or quail hunting seasons, or during wild hog-dog season for the purpose of hunting wild hogs.
