RULE NO: 68A-15.065

RULE TITLE: Specific Regulations for Wildlife Management Areas –
Northeast Region.

PURPOSE AND EFFECT: The purpose of the proposed rule amendment is to revise specific area regulations on Wildlife Management Areas (WMAs) in the Northeast Region and conform to calendar year date changes. The effect of the proposed rule amendment will be to enable the agency to better manage fish and wildlife resources and public use on WMAs.

SUMMARY: The proposed rule amendment would adjust season dates to conform to calendar year changes and revise specific area regulations on Wildlife Management Areas (WMAs) in the Northeast Region as follows:

Buck Lake WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; allow the use of vehicles from 4 a.m. until 1.5 hours after sunset on days open to scouting and hunting; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Caravelle Ranch WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; extend the shooting hours during spring turkey season from 1 p.m. to sunset; extend vehicle access on the area from 2 p.m. to 1 hour after sunset during the spring turkey season; clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply; and shift the first phase special opportunity dove hunts from the first and second Saturday to the second and third Saturday to alleviate overlap with the archery season.

Charles H. Bronson WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Dunns Creek WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Etoniah Creek WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Fort Drum WMA – clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Gores Landing WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Guana River WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; extend the shooting hours during spring turkey season from 1 p.m. to sunset; and extend vehicle access on the area from 2 p.m. to 9 p.m. during Daylight Saving Time and 8 p.m. during Eastern Standard Time during the spring turkey season.

Half Moon WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; change the quota during the archery, muzzleloading gun and general gun season hunts from 75 to 50; extend the shooting hours during spring turkey

season from 1 p.m. to sunset; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Herky Huffman/Bull Creek WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; and persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Jumper Creek WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Lake George WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Lake George WMA, Dexter Mary Farms Unit – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; allow vehicle access from 1.5 hours before sunrise until 1.5 hours after sunset on the Saturday and Sunday prior to each special-opportunity spring turkey hunt; and clarify that during the spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Lake Monroe WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Lake Panasoffkee WMA – shift special-opportunity archery hunts to prevent overlap with the Thanksgiving holiday weekend; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Little Big Econ WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Marshall Swamp WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Matanzas WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Ocala WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Richloam WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Richloam WMA, Baird Unit – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; and persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Rock Springs Run WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest of antlered deer having at least 1 antler with a main beam of 10 inches or more; and persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Ross Prairie WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Salt Lake WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; extend the shooting hours during spring turkey season from 1 p.m. to sunset; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Seminole Forest WMA – as an alternative to existing 3 point antler point restriction, also allow the harvest

of antlered deer having at least 1 antler with a main beam of 10 inches or more; and persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Seminole Forest WMA, Lake Tracy Unit – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Seminole Ranch WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Three Lakes WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Three Lakes WMA, Prairie Lakes Unit – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; extend the shooting hours during spring turkey season from 1 p.m. to sunset; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Tiger Bay WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Tiger Bay WMA, Rima Ridge Unit – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Tosohatchee WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length; and define antlerless deer as any deer, except a spotted fawn, that is without antlers or whose antlers are less than one inch in length visible above the hairline.

Triple N WMA – extend the shooting hours during spring turkey season from 1 p.m. to sunset; extend vehicle access on the area from 2 p.m. to 9 p.m. during the spring turkey season; and clarify that during spring turkey season the area limit of 1 per day and the statewide season limit of 2 apply.

Upper St. Johns River Marsh WMA – harvesting antlered deer not having 1 antler with 3 or more points or 1 antler with a main beam of 10 inches or more is prohibited, except persons less than 16 years of age may harvest any antlered deer with 1 antler 5 inches or more in length.

Additionally, the proposed rule amendment would provide non-substantive technical changes, such as grammatical corrections, language standardization, or clarification of an existing rule.

THE FULL TEXT OF THE PROPOSED RULE IS AS FOLLOWS:

68A-15.065 Specific Regulations for Wildlife Management Areas – Northeast Region.

(1) Herky Huffman/Bull Creek Wildlife Management Area.

(a) Open season:

1. General gun – November ~~7-8~~ ~~1-2~~ and November ~~9~~ ~~3~~ through January 3 ~~December 28~~.
2. Small game – January 4 ~~December 29~~ through March ~~6~~ ~~1~~.
3. Spring turkey – March ~~19~~ ~~21~~ through April ~~24~~ ~~26~~.
4. Archery – September ~~19-20~~ ~~13-14~~ and September ~~21~~ ~~15~~ through October ~~18~~ ~~12~~.
5. Muzzleloading gun – October ~~24-26~~ ~~18-20~~.
6. Youth turkey hunt – March ~~12-13~~ ~~14-15~~.
7. No change.

(b) Legal to take: All legal game, fish, frogs and furbearers. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length, ~~one inch or more in length~~, is prohibited, except by persons less than 16 years of age. Taking wild hog is prohibited during small game season.

(c) through (d) No change.

(2) Ocala Wildlife Management Area.

(a) Open season:

1. General gun – November ~~14~~ 8 through January ~~10~~ 4 (Pipeline, Lake Delancy and Hopkins Prairie units only).
2. General gun dog – November ~~14~~ 8 through ~~22~~ 46 (Church Lake Unit only).
3. General gun still – November ~~28~~ through ~~December 6~~ 22-30 (Church Lake Unit only).
4. Small game – December ~~7~~ 4 through March ~~6~~ 4 (Church Lake Unit only) and January ~~11~~ 5 through March ~~6~~ 4 (Pipeline, Lake Delancy and Hopkins Prairie units only).
5. Archery – September ~~26~~ 20 through October ~~25~~ 49.
6. Muzzleloading gun – ~~October 30 through November 1~~ October 24-26, on the Church Lake, Hopkins Prairie and Lake Delancy units only.
7. Fox, opossum, bobcat and raccoon – November ~~14~~ 8 through April ~~17~~ 42.
8. ~~Special~~ September duck – In the ~~special~~ September duck season established by Rule 68A-13.003, F.A.C.
9. Youth turkey hunt – March ~~12-13~~ ~~14-15~~ (Lake Delancy Unit only).
10. Spring turkey – March ~~24-27~~ ~~26-29~~, March 31 through April 3 ~~April 2-5~~, April 7-10 ~~9-12~~ and 14-17 ~~16-19~~.
11. through 13. No change.

(b) Legal to take:

1. All legal game, fish, frogs and furbearers. During the spring turkey season, ~~the bag limit shall be one gobbler (or bearded turkey) may be taken~~ per person, but not more than two per quota permit. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. Antlered deer may only be taken in the Church Lake Unit during the archery season, muzzleloading gun season the first 9 days of the general gun season and the general gun still season. Deer daily bag one per person. Antlerless deer may not be taken during the archery season.

2. Furbearing animals – During the November ~~14~~ 8 through March 1 period, hunting as specified in paragraph 68A-24.002(2)(b), F.A.C., is allowed only in the Pipeline and Church Lake units. Raccoons may also be hunted, with dogs only, from March ~~7~~ 2 through April ~~17~~ 42 only in that portion of the Pipeline Unit south of S.R. 40 and west of S.R. 19. The hunting of fox and bobcat by the use of dogs only shall be allowed from January ~~11~~ 5 through April ~~17~~ 42, only in that portion of the Pipeline Unit south of S.R. 40 and west of S.R. 19.

(c) No change.

(d) General regulations:

1. through 4. No change.
5. Dogs may be used to pursue rabbits from January ~~11~~ 5 through April ~~17~~ 42 in that portion of the Pipeline Unit south of S.R. 40 and west of S.R. 19.
6. No change.

(e) No change.

(3) Richloam Wildlife Management Area.

(a) Open season:

1. General gun – November ~~21-29~~ ~~22-30~~ and November 30 ~~December 1~~ through January ~~17~~ 48.
2. Spring turkey – March ~~19-27~~ ~~21-29~~ and March ~~28~~ 30 through April ~~24~~ 26.
3. Archery – October ~~17~~ 48 through November ~~15~~ 46.
4. No change.
5. Trapping – January ~~18~~ 49 through March 1.
6. Wild hog-dog – April 29 through May 1 ~~4-3~~.
7. Youth turkey hunt – March ~~12-13~~ ~~14-15~~.
8. No change.

(b) Legal to take: All legal game, fish, frogs and furbearers. Only wild hog may be taken during the wild hog-dog season. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. The take of antlerless deer is prohibited during the archery season.

(c) through (d) No change.

(4) Richloam Wildlife Management Area – Baird Unit.

(a) Open season:

1. Archery – October 31 through November 3 ~~4-4~~, November 4-8 ~~5-9~~ and 9-15 ~~10-16~~.
2. Muzzleloading gun – November 21-23 ~~22-24~~.
3. General gun – January 18-21 ~~19-22~~ and 22-26 ~~23-27~~.
4. Wild hog-still – January 27-29 ~~28-30~~.
5. Youth turkey hunt – March 12-13 ~~14-15~~.
6. Spring turkey – March 19-21 ~~21-23~~, 25-27 ~~27-29~~ and April 1-3 ~~3-5~~.
7. Small game – February 6 ~~January 31~~ through March 6 ~~4~~.
8. No change.

(b) Legal to take: All legal game, fish, frogs and furbearers. One antlered and one antlerless deer may be taken per quota permit during the archery season. One antlered deer may be taken per quota permit during the muzzleloading gun and general gun seasons. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length, ~~one inch or more in length~~, is prohibited, except by persons less than 16 years of age. Only wild hog may be taken during the wild hog-still season.

(c) through (d) No change.

(5) Three Lakes Wildlife Management Area.

(a) Open season:

1. General gun – November 7-8 ~~1-2~~ and November 9 ~~3~~ through January 3 ~~December 28~~.
2. Small game – January 4 ~~December 29~~ through March 6 ~~4~~.
3. Spring turkey – March 19 ~~24~~ through April 24 ~~26~~.
4. Archery – September 19-20 ~~13-14~~ and September 21 ~~15~~ through October 18 ~~12~~.
5. ~~Special~~ September duck – In the ~~special~~ September duck seasons ~~season~~ established by Rule 68A-13.003, F.A.C., in that area between Prairie Lakes Unit and Canoe Creek Road only.
6. Muzzleloading gun – October 24-26 ~~18-20~~.
7. General gun for mobility impaired – October 30 ~~through November 1~~ ~~24-26~~.
8. General gun-dog – December 10-13 ~~4-7~~ and December 31 ~~through January 3~~ ~~25-28~~.
9. through 10. No change.
11. Raccoon – January 15-17 ~~9-11~~, 22-24 ~~16-18~~ and 29-31 ~~23-25~~ (from 1.5 hours before sunset on Friday until 1.5 hours after sunrise on Sunday) in that area between the Florida Turnpike and US 441 only.
12. Youth turkey hunt – March 12-13 ~~14-15~~.

(b) Legal to take: All legal game, fish, alligators as specified in Rule 68A-25.042, F.A.C., frogs and furbearers. The take of wild hog is prohibited during small game season and general-gun dog season. Killing quail is prohibited on the quail enhancement area (that portion of the area lying east of the Florida Turnpike) except by quail permit during the quail season. The bag limit for quail on the quail enhancement area is six (6) per quota permit. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. During the general gun for mobility-impaired season, the bag limit for antlerless deer is one per certified mobility-impaired hunter and only certified mobility-impaired hunters are allowed to take antlerless deer.

(c) through (e) No change.

(6) Three Lakes Wildlife Management Area – Prairie Lakes Unit.

(a) Open season:

1. Archery – October 2-4 and 9-11 ~~September 26-28~~ and October 3-5.
2. Muzzleloading gun – October 30 ~~through November 1~~ ~~24-26~~.
3. General gun – November 20-22 ~~14-16~~ and 27-29 ~~21-23~~.
4. Small game – December 12 ~~through January 3~~ ~~6-28~~.
5. Youth turkey hunt – March 12-13 ~~14-15~~.
6. Spring turkey – March 19-21 ~~21-23~~, April 1-3 ~~3-5~~ and 15-17 ~~17-19~~.
7. No change.

8. Wild hog-still – ~~December 4-6 November 28-30~~ and January ~~8-10 2-4, 29-31 23-25~~ and February ~~26-28 20-22~~.

9. through 10. No change.

(b) Legal to take: All legal game, fish, frogs and furbearers. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. During the archery season, antlerless deer may be taken by antlerless deer permit only. The bag limit for deer shall be one antlered deer per person, but not more than two antlered deer per quota permit. The take of wild hog is prohibited during small game season. During the spring turkey season, ~~the bag limit shall be~~ one gobbler (or bearded turkey) may be taken per person, but not more than two per quota permit. Gobblers or bearded turkeys may be taken during the spring turkey season from one-half hour before sunrise until sunset. Only wild hog may be taken during the wild hog-still season.

(c) Camping through (d) No change.

(7) Tiger Bay Wildlife Management Area.

(a) Open season:

1. General gun – November ~~7-15 1-9~~ and November ~~16 10~~ through January 3 ~~December 28~~.
2. Archery – September ~~19 13~~ through October ~~18 12~~.
3. Muzzleloading gun – October ~~24-26 18-20~~.
4. Small game – January 4 ~~December 29~~ through March ~~6 1~~.
5. Youth turkey hunt – March ~~12-13 14-15~~.
6. Spring turkey – March ~~19-22 21-24~~, March 31 through April 4 ~~April 2-6~~ and April 14-17 ~~16-19~~.
7. No change.

(b) Legal to take:

1. All legal game, fish, except as provided below, frogs and furbearers. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age.

2. No change.

(c) through (d) No change.

(8) Tiger Bay Wildlife Management Area – Rima Ridge Unit.

(a) Open season:

1. General gun – November ~~14-22 8-16~~.
2. Archery – September ~~26 20~~ through October ~~11 5~~.
3. Muzzleloading gun – October ~~30~~ through November 1 ~~24-26~~.
4. Small game – November ~~26 20~~ through January 3 ~~December 28~~.
5. Youth turkey hunt – March ~~12-13 14-15~~.
6. Spring turkey – March ~~19-21 21-23~~, April ~~1-3 3-5~~ and ~~15-17 17-19~~.
7. through 8. No change.

(b) Legal to take: All legal game, fish, frogs and furbearers. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. During the archery, muzzleloading gun and general gun seasons, the bag limit for deer shall be one per person, but not more than two per quota permit. During the spring turkey season, ~~the bag limit shall be~~ one gobbler (or bearded turkey) may be taken per person, but not more than two per quota permit.

(c) through (d) No change.

(9) Tosohatchee Wildlife Management Area.

(a) Open season:

1. Archery – October ~~8-11 2-5~~ and ~~15-18 9-12~~.
2. Muzzleloading gun – October ~~29~~ through November 1 ~~23-26~~ and November 5-8 ~~October 30 through November 2~~.
3. General gun – November ~~19-22 13-16~~ and ~~27-29 21-23~~.
4. Spring turkey – March ~~19-21 21-23~~, April ~~1-3 3-5~~ and ~~15-17 17-19~~.

5. Wild hog-dog – January ~~15-21~~ ~~9-15~~ and February ~~12-18~~ ~~6-12~~.

6. No change.

(b) Legal to take: Antlered deer, antlerless deer, Any deer except spotted fawn, turkey, wild hog, fish, frogs and coyote. No other wildlife species may be taken. Antlerless deer is any deer, except a spotted fawn, that is without antlers or whose antlers are less than one inch in length visible above the hairline. Taking of antlered deer not having at least one antler with three or more points or one antler with a main beam of ten inches or more in length is prohibited, except by persons less than 16 years of age. A limit of one antlerless and one antlered deer per quota permit is established. Only wild hog may be taken during the wild hog-dog season.

(c) through (d) No change.

(10) Seminole Ranch Wildlife Management Area.

(a) Open season:

1. Archery – October ~~9-11~~ ~~3-5~~ and ~~16-18~~ ~~40-42~~.

2. Muzzleloading gun – October ~~30 through November 1~~ ~~24-26~~ and ~~November 6-8~~ ~~October 31 through November 2~~.

3. General gun – November ~~20-22~~ ~~14-16~~.
