**STEP 1: INSTRUCTIONS**

Transfer requests are only accepted from May 1 through the last day of February. Please read the application carefully, and print or type clearly. You must complete the entire application. This form and all fees due must be either sent by certified mail to FWC Office of Licensing and Permitting, 2590 Executive Center Circle, Suite 200, Tallahassee, FL 32301, or hand-delivered to FWC's Office of Licensing and Permitting within **72** hours of being notarized. Both seller and buyer should keep a copy of this form for their records.
