We received the county-approved Clay County Manatee Protection Plan (MPP) on March 30, 2006. We are pleased to provide the Florida Fish and Wildlife Conservation Commission's (FWC) approval of your plan. Realizing that County staff has been working on this for several years, we applaud the effort of County staff and Clay County's proactive approach to manatee protection.

The positive result of this effort is due to the cooperation and hard work of many groups: staff members of Clay County, the Clay County Parks and Recreation Committee, the Clay County Board of County Commissioners, the U. S. Fish and Wildlife Service, and the FWC. The Clay County MPP addresses appropriate locations for future development, while still providing protection for manatees and their habitat in critical-use areas. We think it will bring a successful blend of access and protection to the county's waters.

We look forward to continuing to work cooperatively with County staff to use and implement the provisions outlined in the Clay County MPP. FWC staff is also available for assistance when Clay County amends its comprehensive plan language later this fall.
